1. According to the reports filed with the Secretary of State, the Kansas AFL-CIO COPE Fund PAC reports making a \$750 contribution to Lindsey Constance on 9-17-20. However, your campaign reports this contribution as \$500. Please check your records to determine if this contribution was \$500 as reported by your campaign, or if it was a \$750 contribution. If the contribution was \$750, an amended Schedule A (Contributions and Other Receipts) for the October 26, 2020 report must be filed correcting this error. This error will cause the cash balance on the front page summary sheet to be incorrect. Therefore, an amended front page summary sheet must also be filed. **If the campaign did not receive this contribution, please note this fact in a letter to the Commission.**
2. Schedule C (Expenditures and Other Disbursements) of the October 26, 2020 report lists a donation to the Kansas Federation of Democratic Women in the amount of \$40 on 8-4-20.

K.S.A. 25-4157a does not list a contribution made to a political action committee as one of the permissible uses of a candidate's campaign fund. If this expenditure was for a reimbursable campaign expense, that fact must be noted on an amended Schedule C. If this was an actual donation, the Kansas Federation of Democratic Women will be required to return your campaign funds or you will need to reimburse the campaign personally. **The return of this donation must be shown on Schedule A (Contributions and Other Receipts) on the January 10, 2022 report.**
