

Additional information and assistance may be obtained by writing or calling this office. If after having contacted this office substantial issues remain unresolved, you may within ten (10) days of receipt of this notice request a hearing before the Commission.

1. According to the reports filed with the Secretary of State, the Kansas Insurance PAC reports making a \$250 contribution to Anthony Hensley on 12-21-17. However, the campaign reports this contribution as \$1000. Please check your records to determine if the contribution was \$1000 or \$250. If this contribution was \$250, an amended Schedule A (Contributions and Other Receipts) for the January 10, 2018 report must be filed with the correct amount. This error will cause the cash balance on the front page summary sheet to be incorrect. Therefore, an amended front page summary sheet must also be filed. If the campaign is correct and the amount was \$1000, please note this fact in a letter to the Commission.
2. Schedule C (Expenditures and Other Disbursements) of the January 10, 2018 report lists a contribution to the Kansas Young Democrats in the amount of \$1000 on 2-9-17.

K.S.A. 25-4157a does not list a contribution made to a political action committee as one of the permissible uses of a candidate's campaign fund. If this expenditure was for the purchase of an advertisement in the committee's publications or for other reimbursable campaign expenses, that fact must be noted on an amended Schedule C. If this was an actual donation, the Kansas Young Democrats will be required to return your campaign funds or you will need to reimburse the campaign personally. The return of this donation must be shown on Schedule A (Contributions and Other Receipts) on the January 10, 2019 report.
