- 1. According to the reports filed with the Secretary of State, the Kansas Cable TV PAC reports making a \$250 contribution to Hensley for KS Senate on 9-13-18. This contribution was not reported by your campaign. If this contribution was received, it must be reported on Schedule A (Contributions and Other Receipts) on the January 10, 2019 report. This error will cause the cash balance on the front page summary sheet to be incorrect. Therefore, an amended front page summary sheet must also be filed. If the campaign did not receive this contribution, please note this fact in a letter to the Commission.
- 2. Schedule C (Expenditures and Other Disbursements) of the January 10, 2019 report lists a donation to the Kansans for a Progressive House in the amount of \$250 on 5-1-18. K.S.A. 25-4157a does not list a contribution made to a political action committee as one of the permissible uses of a candidate's campaign fund. If this expenditure was for a reimbursable campaign expense, that fact must be noted on an amended Schedule C. If this was an actual donation, you will need to contact the Kansans for a Progressive House and they will be required to return your campaign funds or you will need to reimburse the campaign personally. The return of this donation must be shown on Schedule A (Contributions and Other Receipts) on the January 10, 2020 report.
