This contribution was not reported by your campaign. If this contribution was received, it must be reported on Schedule A (Contributions and Other Receipts) on the January 10, 2021 report. This error will cause the cash balance on the front page summary sheet to be incorrect. Therefore, an amended front page summary sheet must also be filed. If the campaign did not receive this contribution, please note this fact in a letter to the Commission.
- 2. According to the reports filed with the Secretary of State, the Kansas Democratic Party reports receiving a contribution for \$6,300.00 from Hensley for Senator on 11-9-20.
