Additional information and assistance may be obtained by writing or calling this office. If after having contacted this office substantial issues remain unresolved, you may within ten (10) days of receipt of this notice request a hearing before the Commission.

1. K.S.A. 25-4153 (a)(1) states, "The aggregate amount contributed to a candidate and such candidate's committee . . . shall not exceed the following: for the office of state senator, . . . \$1000 for each primary election . . . and an equal amount for each general election." The Hawk campaign reported receiving a \$500 contribution on 12-27-17 and a \$1000 contribution on 12-23-19 from Spirit Aerosystems, for a total of \$1500. Both of these contributions were received during the primary election period.

Pursuant to K.S.A. 25-4153, the campaign accepted a contribution in excess of the legal limit amounting to \$500. We would suggest that this contribution be refunded immediately. **The return of this contribution should be noted on Schedule C (Expenditures and Other Disbursements) of the July 27, 2020 Receipts and Expenditures Report.**

2. The January 10, 2020 Receipts and Expenditures Report filed by the Riley County Democratic Central Committee lists a \$150 donation from the Hawk for Senate campaign on 10-25-19. This expenditure was not reported by the campaign. If this expenditure was made, an amended Schedule C (Expenditures and Other Disbursements) must be filed listing the donation.
