- 1. According to the verified statements filed with the Secretary of State, Enterprise Holdings, Inc. PAC reports making a \$250 contribution to Oletha Faust-Goudeau on 9-15-20. This contribution was not reported by your campaign. If this contribution was received, it must be reported on Schedule A (Contributions and Other Receipts) on the October 26, 2020 report. This error will cause the cash balance on the front page summary sheet to be incorrect. Therefore, an amended front page summary sheet must also be filed. If the campaign did not receive this contribution, please note this fact in a letter to the Commission.
- 2. Schedule A (Contributions and Other Receipts) of the October 26, 2020 report contains numerous PAC contributions that list an acronym for the PAC, not the complete PAC name. An amended Schedule A must be filed listing the complete name of all contributors.
- 3. Schedule C (Expenditures and Other Disbursements) of the October 26, 2020 report lists a donation to the Sedgwick County Democratic Women in the amount of \$30 on 7-10-20 for membership dues.
 - K.S.A. 25-4157a does not list a contribution made to a political action committee as one of the permissible uses of a candidate's campaign fund. If this expenditure was for a reimbursable campaign expense, that fact must be noted on an amended Schedule C. If this was an actual donation, the Sedgwick County Democratic Women will be required to return your campaign funds or you will need to reimburse the campaign personally. The return of this donation must be shown on Schedule A (Contributions and Other Receipts) on the January 10, 2022 report.
