1. Schedule A (Contributions and Other Receipts) of the January 10, 2020 report lists a \$250 contribution being received on 1-3-19 from the Kansas Bail Agents Association PAC and a \$500 contribution on 1-3-19 from the Kansas Industrial Consumers Group, Inc. K.S.A. 25-4153a states that no registered lobbyist, political committee or person, other than an individual, shall make a contribution and no legislator or candidate for the legislature shall accept a contribution from a lobbyist, political committee or person, other than an individual after January 1 and prior to sine die adjournment of the regular session of the legislature or any other time the legislature is in session. These contributions should not have been accepted and should be returned. **The return of these contributions must be shown on Schedule C (Expenditures and Other Disbursements) of the July 27, 2020 report.**

2. Schedule C (Expenditures and Other Disbursements) of the January 10, 2020 report lists a \$423.81 reimbursement on 1-9-19 and a \$785.51 reimbursement on 5-13-19 to Brian Baumgardner. For reporting purposes, it will be necessary for you to provide a more detailed description of the types of expenses that were reimbursed, i.e., mileage, meals, postage, supplies, etc. If any one expense was over \$50, it must be itemized. An amended Schedule C must be filed disclosing this information.
