- I have verified that this campaign received donations from BCS Design of \$500 on 12/17/21, \$500 on 09/13/22, and \$500 on 11/29/23, totaling \$1,500. As this is more than the \$1,000 limit for senators for the primary cycle which runs 01/01/21 through 08/06/24, I have today refunded the \$500 donation of 11/29/23 and I will report this refund on the 07/29/24 campaign finance report.
- 2. Regarding the donation reported by the Kansans For Quality Mental Health Services PAC on 7/21/23. I became treasurer for the Senator Mary Ware campaign on 08/09/23. I have examined the bank records for the time period 01/01/23 through 07/31/23 and have found no record of a deposit of \$250 from this PAC. The only donation of \$250 during this time period was from the Kansas Hospital Association PAC on 06/14/23 which was reported. I have examined the records kept by me from 08/01/23 to the date of the last report, 01/10/24. It is my practice to xerox copies of all checks and donations from any source and reconcile these with the bank statement each month. I have not found a donation from this PAC. Is it permissible to ask them for a copy of a cancelled check showing receipt by the Senator Mary Ware campaign? I will be happy to correct our records to show receipt of this payment if that is the case.

Thank you so much for your help in this matter. Please let me know if I need to make further corrections to the campaign records for Senator Mary Ware.
