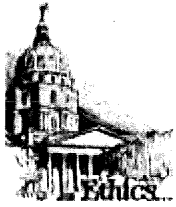

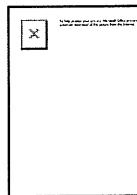
Hi Karina,
