1. The beginning balance of \$28,762.60 listed on the January 10, 2024 report is not the same as the ending balance of \$32,500.00 listed on the January 10, 2023 report. This difference of \$3,737.40 must be explained in an amended report.
2. According to the reports filed with the Secretary of State, Restore Our Backbone for Conservative Values (ROB) PAC reports making a \$1000 contribution on 11-26-23 to Craig Bowser for Kansas. This contribution was not reported by your campaign. If this contribution was received, it must be reported on Schedule A (Contributions and Other Receipts) on the January 10, 2024 report. **If the campaign did not receive this contribution, please note this fact in a letter to the Commission.**
3. The January 10, 2024 report did not disclose a payment to the Secretary of State for the candidate's filing fee that was paid on 3-6-23 in the amount of \$145.00. If the filing fee was paid by the candidate from personal funds, it should be recorded on Schedule B (In-Kind Contributions) as an "in-kind" contribution from the candidate to the campaign. If the filing fee was paid from campaign funds, this expenditure should be listed on Schedule C (Expenditures & Other Disbursements). The January 10, 2024 report must be amended by showing the payment of the filing fee either on Schedule B or Schedule C and on the cover summary page.
4. Schedule A (Contributions and Other Receipts) of the January 10, 2024 report shows a \$65,000.00 loan from Craig Bowser. **All loans should also be listed on Schedule D (Other Transactions) until such time as they are repaid or forgiven.** An amended January 10, 2024 report must be filed which includes Schedule D and the corresponding entry on Line 7 of the cover summary page.
5. Schedule D (Other Transactions) of the **amended** January 10, 2023 Receipts and Expenditures Report lists a loan payable totaling \$30,000.00 to Craig Bowser. The \$30,000.00 loan payable is not carried forward as a loan payable to the January 10, 2024 report, nor is it on Schedule C (Expenditures and Other Disbursements) as repaid. **All loans should be listed on Schedule D (Other Transactions) until such time as they are repaid or forgiven.** An amended January 10, 2024 report must be filed disclosing the disposition of this debt.
