Additional information and assistance may be obtained by writing or calling this office. If after having contacted this office substantial issues remain unresolved, you may within ten (10) days of receipt of this notice request a hearing before the Commission.

 Schedule A (Contributions and Other Receipts) of the July 29, 2024 report lists a \$200 cash contribution on 07-01-24 as "Anonymous Cash".

K.S.A. 25-4154 (b) states, "No person shall give or accept any contribution in excess of \$10 unless the name and address of the contributor is known to the individual receiving the contribution." If the campaign is not aware of the name of the contributor(s) of this contribution, \$200 must be expended in a non-political manner since this would be an illegal contribution. An explanation of this contribution must be provided in a letter or e-mail to the Commission.

- 2. Schedule C (Expenditures and Other Disbursements) lists expenditures to Christina Haswood during the reporting period in the amount of \$1,350.00 for reimbursement. It will be necessary for you to provide a more detailed description of the types of expenses which were reimbursed, i.e., mileage, meals, postage, supplies, reimbursement for radio, newspaper, TV advertising, etc. If any one expense was over \$50 it must be itemized. An amended Schedule C for the July 29, 2024 report must be filed disclosing this information.

K.S.A. 25-4153(i) states, "No person shall make any contribution or contributions to any candidate or the candidate committee of any candidate in the form of money or currency of the United States which in the aggregate exceeds \$100 for any one primary or general election, and no candidate or candidate committee of any candidate shall accept any contribution or contributions in the form of money or currency of the United States which in the aggregate exceeds \$100 from any one person for any one primary or general election."

The cash contribution listed above should not have been accepted by the campaign. In the future, you must be certain that all contributions in excess of \$100 are made

by check, cashier's check, money order or e-funds. No amendment is required for this error.
