- 1. The July 29, 2024 report did not disclose a payment to the Secretary of State for the candidate's filing fee that was paid on 5-31-24 in the amount of \$145.00. If the filing fee was paid by the candidate from personal funds, it should be recorded on Schedule B (In-Kind Contributions) as an "in-kind" contribution from the candidate to the campaign. If the filing fee was paid from campaign funds, this expenditure should be listed on Schedule C (Expenditures & Other Disbursements). The July 29, 2024 report must be amended by showing the payment of the filing fee either on Schedule B or Schedule C and on the cover summary page.
- 2. Schedule D (Other Transactions) of the July 29, 2024 report shows loans from the candidate totaling \$321.37 during this reporting period. If these loans were paid directly from the candidate's personal account, they should <u>also</u> be listed on Schedule B (In-Kind Contributions). An amended report must be filed which includes these in-kind contributions from the candidate on Schedule B and the corresponding entry on Line 6 of the cover summary page.
- 3. Schedule A (Contributions and Other Receipts) of the July 29, 2024 report shows a \$500.00 loan from Benee Hudson. All loans should also be listed on Schedule D (Other Transactions) until such time as they are repaid or forgiven. An amended report must be filed which includes Schedule D and the corresponding entry on Line 7 of the cover summary page.
- 4. Schedule A (Contributions and Other Receipts) indicates your campaign accepted the following cash contribution over \$100:

K.S.A. 25-4153(i) states, "No person shall make any contribution or contributions to any candidate or the candidate committee of any candidate in the form of money or currency of the United States which in the aggregate exceeds \$100 for any one primary or general election, and no candidate or candidate committee of any candidate shall accept any contribution or contributions in the form of money or currency of the United States which in the aggregate exceeds \$100 from any one person for any one primary or general election."

The cash contribution listed above should not have been accepted by the campaign. In the future, you must be certain that all contributions in excess of \$100 are made by check, cashier's check, money order or e-funds. No amendment is required for this error.
