Administration of Campaign Finance, Conflict of Interest & Lobbying Laws 1. K.S.A. 25-4153 (a) (1) states, "The aggregate amount contributed to a candidate and such candidate's committee . . . shall not exceed the following: for the office of state senator or member of the state board of education, . . \$1000 for each primary election . . . and an equal amount for each general election." The Sykes campaign reported receiving the following contributions:

These contributions were received during the primary election period which is January 1, 2021 through August 6, 2024 for senators.

Pursuant to K.S.A. 25-4153, the campaign accepted contributions in excess of the legal limit amounting to \$2500. We would suggest that these contributions be refunded immediately. The return of these contributions should be noted on Schedule C (Expenditures and Other Disbursements) of the July 29, 2024 report.

- 2. According to the verified statement filed with the Secretary of State, the IBEW Local #124 Voluntary PAC reports making a \$1000 contribution on 7-13-23 to Dinah Sykes. This contribution was not reported by your campaign. If this contribution was received, it must be reported on Schedule A (Contributions and Other Receipts) on the January 10, 2024 report. Also, the Sykes campaign reported receiving a \$1000 contribution on 7-25-22 from the PAC, therefore, if the additional \$1000 contribution was received, it must be returned since it would be an excess contribution in the amount of \$1000. If the campaign did not receive this contribution, please note this fact in a letter to the Commission.
- 3. On August 3, 2023, a Notification of Material Error or Omission In A Receipts and Expenditures Report was mailed to the Sykes campaign regarding an excess contribution during the primary election period in the amount of \$350 from Jennifer Wampler. The return of this excess contribution was not reported on Schedule C (Expenditures and Other Receipts) of the January 10, 2024 report. If it was returned, an amended Schedule C for the January 10, 2024 report must be filed listing the return. If the \$350 excess contribution has not been returned, it must be done so immediately and reported on Schedule C of the July 29, 2024 report.
