1. The January 10, 2023 report that was filed on behalf of the Renee Erickson for **state senate** campaign was completed with the October 31, 2022 front page summary sheet. A January 10, 2023 report which covers the period from January 1, 2022 through December 31, 2022 must be filed.
2. The beginning balance of \$21,320.73 listed on the January 10, 2023 report is not the same as the ending balance of \$22,411.44 listed on the January 10, 2022 report. This difference of \$1,090.71 must be explained in an amended report.
