1. Schedule D (Other Transactions) of the July 29, 2024 report lists a \$1000 loan payable to Jason Miller. However, Schedule C (Expenditures and Other Disbursements) of the report indicates the \$1000 loan was repaid on 4-15-24. If this loan was repaid, an amended Schedule D and front page summary sheet must be filed removing this loan payable. Only outstanding loans at the end of the reporting period should be listed on Schedule D until they are paid or forgiven.
2. Schedule A (Contributions and Other Receipts) indicates your campaign accepted the following cash contribution over \$100:

K.S.A. 25-4153(i) states, "No person shall make any contribution or contributions to any candidate or the candidate committee of any candidate in the form of money or currency of the United States which in the aggregate exceeds \$100 for any one primary or general election, and no candidate or candidate committee of any candidate shall accept any contribution or contributions in the form of money or currency of the United States which in the aggregate exceeds \$100 from any one person for any one primary or general election."

The cash contribution listed above should not have been accepted by the campaign. In the future, you must be certain that all contributions in excess of \$100 are made by check, cashier's check, money order or e-funds. **No amendment is required for this error.**
