Additional information and assistance may be obtained by writing or calling this office. If after having contacted this office substantial issues remain unresolved, you may within ten (10) days of receipt of this notice request a hearing before the Commission.

1. Schedule B (In-Kind Contributions) of the July 29, 2024 report lists a \$200 in-kind contribution from Sherry Giebler on 5-30-24 for account setup. If this \$200 was to open the campaign account, it should be listed on Schedule A (Contributions and Other Receipts), not Schedule B. All contributions and other receipts deposited into the campaign bank account should be listed on Schedule A, not Schedule B. An amended report must be filed correcting this error.
2. Schedule A (Contributions and Other Receipts) indicates your campaign accepted the following cash contribution over \$100:

K.S.A. 25-4153(i) states, "No person shall make any contribution or contributions to any candidate or the candidate committee of any candidate in the form of money or currency of the United States which in the aggregate exceeds \$100 for any one primary or general election, and no candidate or candidate committee of any candidate shall accept any contribution or contributions in the form of money or currency of the United States which in the aggregate exceeds \$100 from any one person for any one primary or general election."

The cash contribution listed above should not have been accepted by the campaign. In the future, you must be certain that all contributions in excess of \$100 are made by check, cashier's check, money order or e-funds. **No amendment is required for this error.**
