Please accept this letter as an amendment to the Receipts and Expenditures Report
of the Kathleen Sebelius Committee for the period January 1, 2006 thru
July 20, 2006.

1. A contribution of \$200.00 was inadvertently accepted from John D. Mosier,
P.A. during the legislative session. This contribution was refunded on August
24, 2006 and will appear on Schedule C of the October 30, 2006 report.
- 2.(A) Contributions received from two individuals with the name Richard Katz were
inadvertently attributed to the same individual making it appear that he had
exceeded the statutory limit of \$2000.00 for the primary election. However, it
was discovered that the contributions were actually from separate individuals
and, when attributed correctly, neither individual exceeded the \$2000.00
contribution limit.
- 2.(B) Contributions were inadvertently accepted from Poe & Associates which
resulted in a cumulative total amount that exceeded the statutory limit for the
primary cycle. This contribution was refunded on August 24, 2006 and will
appear on Schedule C of the October 30, 2006 report.
