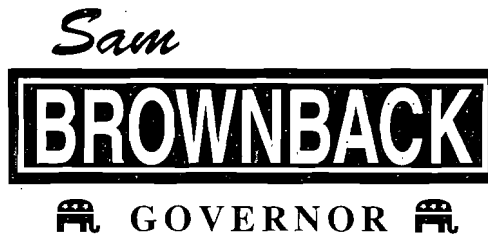

Per your letter of October 8, 2010, the following actions have been taken with regard to our Receipts and Expenditures Report for the period January 1, 2010, through July 22, 2010:
