We have completed the review of the October 25, 2010 and the January 10, 2011 Receipts & Expenditures Reports you filed on behalf of the Sandy Praeger for Insurance Commissioner campaign.

During the review, we found an in-kind contribution in the amount of \$833.33 that was received from the Kansas Republican Party on October 27, 2010. This in-kind contribution should have been shown on the Last Minute Contribution Report and filed with the Secretary of State on October 28, 2010.

In the future, you must be certain that any last minute contributions of \$300 or more are reported on the appropriate date. The failure to do so may result in a civil fine being assessed by the Governmental Ethics Commission.

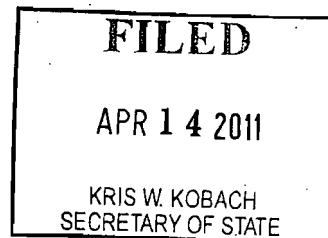


