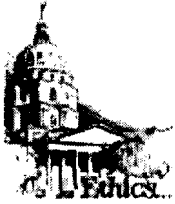

The following corrections should be applied to our 2013 report:


9/26/13 - \$2,000 – AFL-CIO Tri-County Labor Council should be removed.


