Per your letter of September 28, 2018, our \$650 disbursement to the Olathe Republican Party on June 30 was for campaign expenses. We paid \$50 for a double booth space for our signage and campaign materials. The additional \$600 was for the cost of feeding our volunteers at the BBQ buffet. We told our volunteers we would cover their meal cost if they attended. Between 150 and 180 were present and the Party suggested the \$600 fee to cover the food.

Also attached is a breakdown of how the \$794,600 paid to Target Enterprises for Radio/TV advertising from January 1, 2018 through July 26, 2018, was expended.
