Additional information and assistance may be obtained by writing or calling this office. If after having contacted this office substantial issues remain unresolved, you may within ten (10) days of receipt of this notice request a hearing before the Commission.

1. Schedule C (Expenditures and Other Disbursements) of the July 30, 2018 report lists a donation to the Olathe Republican Party in the amount of \$650 on 6-30-18.

K.S.A. 25-4157a does not list a contribution made to a political action committee as one of the permissible uses of a candidate's campaign fund. If this expenditure was for the purchase of an advertisement in the committee's publications or for other reimbursable campaign expenses, that fact must be noted on an amended Schedule C. If this was an actual donation, the Olathe Republican Party will be required to return your campaign funds or you will need to reimburse the campaign personally. The return of this donation must be shown on Schedule A (Contributions and Other Receipts) on the October 29, 2018 report.

2. K.S.A. 25-4148 (b) (7) requires that when an expenditure is made by payment to an advertising agency, public relations firm or political consultants for disbursement to vendors, the report of such expenditure shall show in detail the name of each such vendor and the amount, date and purpose of the payment to each. Expenditures amounting to \$794,600.00 were made to Target Enterprises for "Radio/TV Advertising". Please submit the required supplemental information as an amendment to Schedule C on the July 30, 2018 Receipts and Expenditures Report.
