Dear Ms. Renna,

I hope this letter finds you well. I recently received your letters dated June 5, 2023, and have thoroughly researched the issues you raised. Firstly, I want to express my thanks for bringing to our attention the errors in our last-minute report, specifically the omission of four contributions amounting to \$300 or more. Moving forward, we will implement a streamlined process to ensure that all such contributions are accurately included in the last-minute report.

Regarding the alleged \$2,000 contribution from the KC Regional Realtors PAC, I can confirm and inform you that we have no record of receiving such a contribution. Our internal records do not show that contribution, and our bank account has been reconciled. We have found no evidence of having received that contribution. If you need anything further from me on this issue, please do not hesitate to reach out.


Now, addressing the concerns mentioned in issue number 1 of your letters, we have made amendments to Schedule C on both the October 31, 2022, and January 10, 2023, disclosure reports. During our review, we discovered that our campaign finance system automatically classified numerous payments to GPS Impact as "Miscellaneous Advertising" instead of correctly categorizing them as "Radio/TV" or fundraising expenses. We have reviewed each entry and submitted amended Schedule C reports to the Kansas Secretary of State's office to rectify these errors.

I would also like thank you for drawing our attention to the issue of the cash contribution from Adam Lukens. Though you noted that we do not need to amend our reports, I felt it was necessary to determine the source of the error. It has been determined that the contribution from Adam Lukens was in the form of a check and was mistakenly recorded as "cash." To address this error, we have amended the appropriate Schedule A to reflect that it was, in fact, a check contribution. If you need anything further from me on this issue, please let me know.

To the best of my knowledge, we have now addressed all the errors mentioned in your letter that required amendments. However, if there are any unintentional oversights or further corrections that may be needed, please do not hesitate to bring them to my attention.
