 - K.S.A. 25-4157a does not list a contribution made to a political action committee as one of the permissible uses of a candidate's campaign fund. If this expenditure was for a reimbursable campaign expense, that fact must be noted on an amended Schedule C. If this was an actual donation, the Johnson County Young Republicans will be required to return your campaign funds or you will need to reimburse the campaign personally. The return of this donation must be shown on Schedule A (Contributions and Other Receipts) on the July 25, 2022 report.
- 2. Schedule C (Expenditures and Other Disbursements) of the January 10, 2022 report lists expenditures totalling \$13,635.86 to Delullo & Associates LLC and \$9,641.16 to Leadbelt Strategies LLC for "Fundraising Expenses".
