Dear Mr. Thornburgh:

I have included the amended reports for Oct. 27, 2008 and Jan 10, 2009 as you have requested. The difference of \$568.82 can be explained as an accounting error. The July 28, 2008 report showed cash on hand at the beginning of the period to be \$\frac{4}{614.00}\$. This was an error and should have been \$\frac{4}{1182.82}\$ as was correctly reported on my July 28, 2008 report showing cash on hand at the end of that period to be \$\frac{4}{1},182.82\$.
