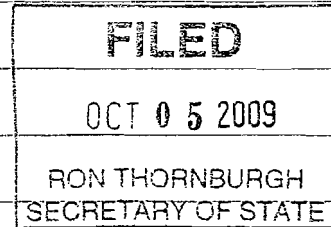

Hear Mr. Thornburgh:

I have included the amended reports for Oct. 27, 2008 and Jan 10, 2009 as you have requested. The difference of \$568.82 can be explained as an accounting error. The July 28, 2008 report showed cash on hand at the beginning of the period to be \$614.00 I also reported in the Oct 27, 2008 that cash on hand at the beginning of the period was \$614.00. This was an error and should have been \$1182.82 as was correctly reported on my July 28, 2008 report showing cash on hand at the end of that period to be \$1,182.82 Therefore the amended report of Jan 10, 2009 will reflect an increase of \$568.82 with cash on hand at the beginning of the period to be \$2780.87.

I apologize for the error and promise to show greater diligence in the future.
