RE: Amended January-10, 2009 Receipts and Expenditures Report

In checking with the Secretary of State's Office, we have been informed that you have failed to file the **amended** Receipts and Expenditures Report identified above as required by law. Such report, a blank copy of which is enclosed for your use, must be completed and filed within five (5) days from the date of receipt of this notice.

As provided by K.S.A. 25-4152, you have until **November 20, 2009**, which is 15 days from the date of this notice, to comply with the reporting requirements before a \$10 per day civil penalty is imposed for each day the required document remains unfiled. No civil penalty shall exceed three hundred dollars (\$300). Also, there are criminal penalties for intentionally failing to file. The intentional failure to file the required report within five (5) days is a class A misdemeanor. In addition, you may not accept contributions or make expenditures until the required report has been filed.

File the required report within five (5) days with the Secretary of State. As provided by law, a copy of this notice has been made a part of your record in the Secretary of State's Office.

1. Schedule C of the January 10, 2009 Receipts and Expenditures Report lists an expenditure to the Wichita Eagle on 10/29/2008 in the amount of \$1,605.13. According to the Last Minute Report filed on October 30, 2008, this printing/printer was an Independent Expenditure in opposition to Dick Kelsey.

2. Schedule C also lists an expenditure to Zoller Lutz Weinbager LLC on 10/30/2008 in the amount of \$810.84. According to the Last Minute Daily Report filed on 10/31/2008, this expenditure was an Independent Expenditure concerning the campaigns of Elizabeth Bishop and Susan Wagle for phone calling.

K.S.A 25-4148 (c) states... "In addition to the requirements of subsection (b), every treasurer for any political committee and party committee shall report the following:

(B) the name and address of each candidate for state or local office who is the subject of any expenditure which:

- (i) Is made without the cooperation or consent of a candidate or candidate committee;
- (ii) expressly advocates the nomination, election or defeat of such candidate; and
- (iii) is an aggregate amount or having a fair market value in excess of \$300."

An amended January 10, 2009 Receipts and Expenditures Report must be filed to list the name and address of each candidate for whom an independent or in-kind expenditure in excess of \$300 was made.
