Dear Ms. Williams,

Enclosed please find the amended January 10, 2012 and July 30, 2012 Receipt & Expenditures Reports for the Sedgwick County Republican Central Committee. These reports reflect computation errors when adding the pages of Schedule C.

In addition to correcting these computation errors, two corrections were made to reported expenditures. On the January 10, 2012 report, a January 15, 2011 expenditure to Lora Cox was listed as \$978.46. The corrected amount of \$1,028.00 is now listed. An additional July 25, 2011 expenditure of \$3.00 to Donor Town Square has been listed. These changes, in addition to computation corrections, amends the total expenditures from \$33,978.39 to \$35,896.29. This correction amends the cash on hand at the close of period from \$11,269 to \$9,351.

On the July 30, 2012 report, the cash on hand at beginning of period has been changed to \$9,351 from \$11,269.00 reflecting the amendments of the January 10, 2012 report. This amendment changes the CASH AVAILABLE amount from \$42,867.52 (as listed on the original report) to \$40,942.62. An addition error on the Summary Page of Schedule C has been amended from \$14,750.95 to the correct amount of \$30,000.50. This changes the Cash on Hand at close of period to \$10,946.12.
