**THIS AFFIDAVIT MUST BE FILED WITH THE SECRETARY OF STATE (120 SW 10<sup>th</sup>, 1<sup>st</sup> Floor Memorial Hall, TOPEKA, KANSAS 66612) PRIOR TO JANUARY 10, 2012.** If a party or political action committee qualifies for this exemption, a Statement of Organization still must be filed and the treasurer must maintain the required records. (K.S.A. 25-4145)

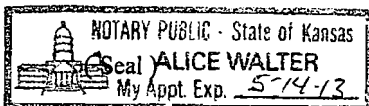
