1. Schedule A (Contributions and Other Receipts) of the January 10, 2008 report lists a \$100 contribution being received on 1-6-07 from the Kansas Building Industry Association, Inc. and a \$50 contribution from the Kansas Dairy Association PAC on 1-6-07. K.S.A. 25-4153a states that no registered lobbyist, political committee or person, other than an individual, shall make a contribution and no legislator or candidate for the legislature shall accept a contribution from a lobbyist, political committee or person, other than an individual after January 1 and prior to sine die adjournment of the regular session of the legislature or any other time the legislature is in session. These contributions should not have been accepted and should be returned. The return of these contributions must be shown on Schedule C (Expenditures and Other Disbursements) of the next receipts and expenditures report your campaign is required to file.

2. The cover summary page of the January 10, 2008 report contains an \$800 subtraction error. The cash on hand at close of period should be \$8943.46, not \$8143.46 as listed. An amended cover summary page must be filed with the correct totals.
