

These errors will cause the cash balance on the front page summary sheet to be incorrect. Therefore, an amended front page summary sheet must also be filed. If the campaign did not receive these contributions, please note this fact in a letter to the Commission.

2. Schedule C (Expenditures and Other Disbursements) of the October 27, 2008 report indicates \$4414.25 was repaid to the candidate on 9-14-08 for loans. However, Schedule D (Other Transactions) of the July 28, 2008 report indicates \$4050.76 was owed to the candidate for outstanding loans. This difference of \$363.49 must be explained in an amended report.
