1. According to the reports filed with the Secretary of State, Builders Association of Kansas PAC reports making a \$100 contribution to Melody McCray-Miller on 10-20-08. This contribution was not reported by your campaign. If this contribution was received, it must be reported on Schedule A (Contributions and Other Receipts) on the October 27, 2008 report. This error will cause the cash balance on the front page summary sheet to be incorrect. Therefore, an amended front page summary sheet must also be filed. If the campaign did not receive this contribution, please note this fact in a letter to the Commission.

2. According to the reports filed with the Secretary of State, Kansans For A Democratic House reports receiving a \$300 contribution from the campaign for Melody McCray-Miller on 7-29-08. This expenditure was not reported by your campaign. If this expenditure was made, it must be reported on Schedule C (Expenditures and Other Disbursements) on the October 27, 2008 report. This error will cause the cash balance on the front page summary sheet to be incorrect. Therefore, an amended front page summary sheet must also be filed. If the campaign did not make this expenditure, please note this fact in a letter to the Commission.
