K.S.A. 25-4153a states that no registered lobbyist, political committee or person, other than an individual, shall make a contribution and no legislator or candidate for the legislature shall accept a contribution from a lobbyist, political committee or person, other than an individual after January 1 and prior to sine die adjournment (**May 29, 2008**) of the regular session of the legislature or any other time the legislature is in session. These contributions should not have been accepted and should be returned. The return of these contributions must be shown on Schedule C (Expenditures and Other Disbursements) of the October 27, 2008 report.

2. Schedule A (Contributions and Other Receipts) lists a \$47 cash contribution received on 3-12-08 and a \$20 cash contribution on 3-20-08 with the notation "Unknown Contributor".

K.S.A. 25-4154 (b) states, "No person shall give or accept any contribution in excess of \$10 unless the name and address of the contributor is known to the individual receiving the contribution." An explanation of these two contributions must be provided. If the campaign is not aware of the names of the contributors of these two contributions, \$67 must be expended in a non-political manner since these would be illegal contributions. An explanation of these contributions must be provided in a letter to the Commission.
