The intentional failure to file an amended report within thirty (30) days is a class A misdemeanor. In addition, you may not accept contributions or make expenditures following the end of the thirty (30) day period if the amended report has not been filed.

Additional information and assistance may be obtained by writing or calling this office. If after having contacted this office substantial issues remain unresolved, you may within ten (10) days of receipt of this notice request a hearing before the Commission.

1. Schedule A (Contributions and Other Receipts) of the July 26, 2010 report lists \$4118.53 in contributions/loans from the candidate. They are also listed on Schedule B (In-Kind Contributions). Any expenditures made by the candidate from personal funds which are not deposited into a campaign bank account are to be reported on Schedule B as in-kind contributions from the candidate as well as Schedule D (Other Transactions). Only contributions deposited in the campaign bank account and expenditures made from that account are to be reported on Schedules A and C. An amended report must be filed correcting this error.

2. According to the reports filed with the Secretary of State, the Johnson County Democratic Women reports making a \$150 contribution to Milack Talia on 12-28-09. This contribution was not reported by your campaign. If this contribution was received, it must be reported on Schedule A (Contributions and Other Receipts) on the July 26, 2010 report. This error will cause the cash balance on the front page summary sheet to be incorrect. Therefore, an amended front page summary sheet must also be filed. If the campaign did not receive this contribution, please note this fact in a letter to the Commission.
