

As provided by law, a copy of this notice has been made a part of your record in the Secretary of State's Office. The intentional failure to file an amended report within thirty (30) days is a class A misdemeanor. In addition, you may not accept contributions or make expenditures following the end of the thirty (30) day period if the amended report has not been filed.

Additional information and assistance may be obtained by writing or calling this office. If after having contacted this office substantial issues remain unresolved, you may within ten (10) days of receipt of this notice request a hearing before the Commission.

1. The beginning balance of \$430.54 on the July 26, 2010 report is not the same as the ending balance of \$251.58 on the January 10, 2010 report. An amended July 26, 2010 report must be filed explaining this \$178.96 discrepancy.
2. The expenditures listed on Schedule C (Expenditures and Other Disbursements) of the July 26, 2010 report total \$12,307.44, not \$8894.78 as indicated on the cover summary page. The cover summary page must be amended to show the correct total of expenditures made during the reporting period, \$12,307.44.
3. The July 26, 2010 report did not disclose a payment to the Secretary of State for the candidate's filing fee. If the filing fee was paid by the candidate from personal funds, it should be recorded on Schedule B (In-Kind Contributions) as an "in-kind" contribution from the candidate to the campaign. If the filing fee was paid from campaign funds, this expenditure should be listed on Schedule C (Expenditures & Other Disbursements). The July 26, 2010 report must be amended by showing the payment of the filing fee either on Schedule B or Schedule C and on the cover summary page.
4. Schedule A (Contributions and Other Receipts) lists \$14.21 in transaction charges. These transaction charges need to be listed on Schedule C (Expenditures and Other Disbursements), not Schedule A. An amended Schedule A and Schedule C must be filed correcting this error.
