

K.S.A. 25-4151 (d) states, "No treasurer shall accept or permit to be accepted any contributions or make or permit to be made any expenditures unless all reports or statements required of such treasurer prior to the time of such contributions or expenditures have been filed." The following contributions were received before the October 25, 2010 report was filed by the Kleeb campaign on November 4, 2010:

The contributions listed above should not have been accepted by the campaign. In the future, please be certain all reports and statements are filed on a timely basis.

2. According to the reports filed with the Secretary of State, the Johnson County Republican Party reports receiving a \$500 contribution from the Kansans for Kleeb on 11-2-10. This expenditure was not reported by your campaign. If this expenditure was made, it must be reported on Schedule C (Expenditures and Other Disbursements) on the January 10, 2011 report. This error will cause the cash balance on the front page summary sheet to be incorrect. Therefore, an amended front page summary sheet must also be filed. If the campaign did not make this expenditure, please note this fact in a letter to the Commission.
