K.S.A. 25-4153 (a)(1) states, "The aggregate amount contributed to a candidate and such candidate's committee . . . shall not exceed the following: for member of the house of representatives, . . . \$500 for each primary election . . . and an equal amount for each general election." The Randall campaign reported receiving a \$200 contribution on 9-19-12 from D Wild Ones PAC and an additional \$500 on 10-31-12, for a total of \$700. Both of these contributions were received during the general election period.

Pursuant to K.S.A. 25-4153, the campaign accepted a contribution in excess of the legal limit amounting to \$200. This contribution must be refunded immediately. Since the campaign bank account is closed, it will be necessary for the candidate to personally reimburse the D Wild Ones PAC. A copy of the cancelled check must be sent to the Commission.
