As provided by law, a copy of this notice has been made a part of your record in the Secretary of State's Office. The intentional failure to file an amended report within thirty (30) days is a class A misdemeanor. In addition, you may not accept contributions or make expenditures following the end of the thirty (30) day period if the amended report has not been filed.

Additional information and assistance may be obtained by writing or calling this office. If after having contacted this office substantial issues remain unresolved, you may within ten (10) days of receipt of this notice request a hearing before the Commission.

1. Schedule D (Other Transactions) of the July 30, 2012 Receipts and Expenditures Report lists loans payable in the amount of \$300 to Willie Dove. This loan balance is not carried forward as a loan payable to the October 29, 2012 Receipts and Expenditures Report. All loans should be listed on Schedule D (Other Transactions) until such time as they are repaid or forgiven. An amended October 29, 2012 report must be filed disclosing the disposition of this debt.
2. Line 4 (Total Expenditures and Other Disbursements) on the cover summary page of the October 29, 2012 report contains a \$28.20 error. The expenditures listed on Schedule C total \$5962.40, not \$5990.60 as indicated on the cover summary page. An amended cover summary page must be filed with the correct totals.
3. Schedule C (Expenditures and Other Disbursements) must be amended to include the street or mailing addresses for all individuals and vendors to whom expenditures were made during the October 29, 2012 reporting period.
4. Schedule C (Expenditures and Other Disbursements) lists an \$85.06 expenditure on 9-28-12 with no name and address or purpose of expenditure. An amended Schedule C must be filed with the name and address of the individual or vendor to whom the expenditure was made and the purpose.
5. Schedule A (Contributions and Other Receipts) of the October 29, 2012 report lists two \$500 contributions received from the Kansas Chamber PAC on 9-18-12. However, the Kansas Chamber PAC reports giving only one \$500 contribution to the Dove campaign on that date. If the contribution was reported twice by your campaign, an amended Schedule A must be filed removing the duplicate entry.
6. Schedule C (Expenditures and Other Disbursements) of the October 29, 2012 report lists expenditures totaling \$292.57 for fuel and gas. Pursuant to Advisory Opinion 2007-14, the candidate can only be reimbursed for mileage at the state mileage reimbursement rate. The candidate can not be reimbursed for fuel. The Commission opined "due to the difficulty in determining the allocation of vehicle expenses between a candidate's personal use of a vehicle and the candidate's use of a vehicle for holding political office or for campaign purposes, the Commission now determines that beginning January 1, 2008, the use of campaign funds to pay for otherwise un-reimbursed vehicle expenses will be limited to the state mileage reimbursement rate." When claiming reimbursement for mileage from campaign funds, the treasurer needs to keep detailed records for mileage expenditures showing the dates of travel, the necessity for and specific purpose of the travel, and the actual mileage traveled. It will be necessary for

the candidate to reimburse the campaign account for the fuel purchased. This reimbursement will need to be disclosed on Schedule A (Contributions and Other Receipts) on the January 10, 2014 Receipts and Expenditures Report. The candidate can be reimbursed for the miles driven at the state rate of 55 cents per mile. If done, this expenditure would be disclosed on Schedule C (Expenditures and Other Disbursements) on the January 10, 2014 report.
