1. According to the Candidate Last Minute Contribution Report filed on 7-30-12 by the Marlys Shulda campaign, the campaign received a \$500 contribution on 7-27-12 from K-7 Liquor Store. This contribution was not reported by your campaign on the October 29, 2012 report. This contribution must **also** be reported on Schedule A (Contributions and Other Receipts) on the October 29, 2012 report. This error will cause the cash balance on the front page summary sheet to be incorrect. Therefore, an amended front page summary sheet must also be filed.

2. Schedule D (Other Transactions) of the October 29, 2012 Receipts & Expenditures Report lists a \$393.48 loan to Brian Shulda and a \$16.70 loan to Marlys Shulda. These loans are not listed on Schedule A (Contributions and Other Receipts) or on Schedule B (In-Kind Contributions). An amended Schedule A must be filed listing these contributions if they were deposited into the campaign account. If these loans were expenditures made from personal funds on behalf of the campaign, they must be listed on an amended Schedule B.
