Additional information and assistance may be obtained by writing or calling this office. If after having contacted this office substantial issues remain unresolved, you may within ten (10) days of receipt of this notice request a hearing before the Commission.

These contributions were not reported by your campaign. If these contributions were received, they must be reported on Schedule A (Contributions and Other Receipts) on the October 29, 2012 report. These errors will cause the cash balance on the front page summary sheet to be incorrect. Therefore, an amended front page summary sheet must also be filed. If the campaign did not receive these contributions, please note this fact in a letter to the Commission.

2. Schedule A (Contributions and Other Receipts) of the October 29, 2012 Receipts and Expenditures Report lists a contribution from Dwayne Umbarger for \$500 on 10-24-12.

K.S.A. 25-4157a (c) states, "No candidate or candidate committee shall accept from any other candidate or candidate committee for any candidate for local, state, or national office, any moneys received by such candidate or candidate committee as a campaign contribution . . ." Since this was a contribution from the candidate's campaign committee, it will be necessary for you to return the \$500 contribution to the Umbarger campaign.

The return of this contribution should be noted on Schedule C (Expenditures and Other Disbursements) of the January 10, 2014 Receipts and Expenditures Report.
