Additional information and assistance may be obtained by writing or calling this office. If after having contacted this office substantial issues remain unresolved, you may within ten (10) days of receipt of this notice request a hearing before the Commission.

1. Schedule A (Contributions and Other Receipts) of the January 10, 2016 report lists a \$200 contribution being received on 1-7-15 from KS WSW PAC. K.S.A. 25-4153a states that no registered lobbyist, political committee or person, other than an individual, shall make a contribution and no legislator or candidate for the legislature shall accept a contribution from a lobbyist, political committee or person, other than an individual after January 1 and prior to sine die adjournment of the regular session of the legislature or any other time the legislature is in session. This contribution should not have been accepted and should be returned. The return of this contribution must be shown on Schedule C (Expenditures and Other Disbursements) of the July 25, 2016 report.

2. Schedule D (Other Transactions) of the January 10, 2016 report shows a \$72.36 loan payable to Lonnie Clark on 8-20-15. All loans should be listed on Schedule A (Contributions and Other Receipts) if the contributions were deposited into the campaign bank account. If the \$72.36 was for expenditures paid from personal funds, it should be recorded on Schedule B (In-Kind Contributions) as an "in-kind" contribution from the candidate to the campaign. An amended report must be filed which includes this loan on Schedule A or Schedule B.
