1. The beginning balance of \$12,545.04 listed on the July 27, 2020 report is not the same as the ending balance of \$12,663.04 listed on the **amended** January 10, 2020 report. An amended front page summary sheet must be filed correcting this error.
2. Schedule A (Contributions and Other Receipts) contains a \$500.00 addition error. The contributions listed on Schedule A total \$7525.00, not \$7025.04 as indicated on the front page summary sheet. An amended front page summary sheet must be filed correcting this error.
3. Schedule A (Contributions and Other Receipts) of the July 27, 2020 report lists a \$250 contribution from Farmers Employee PAC on 6-16-20. The Farmers Insurance Employee and Agent PAC reports the contribution given to the Dierks campaign on 6-16-20 as \$500. Please check your records to determine the amount of this contribution. If the contribution was \$500, not \$250, an amended Schedule A must be filed listing the correct amount.
4. According to the reports filed with the Secretary of State, the following PAC's report making contributions to the Dierks campaign:
