1. According to the reports filed with the Secretary of State, the HCA Kansas Good Government Fund PAC reports making a \$250 contribution to J C Moore on 11-18-19. This contribution was not reported by your campaign. If this contribution was received, it must be reported on Schedule A (Contributions and Other Receipts) on the January 10, 2020 report. This error will cause the cash balance on the front page summary sheet to be incorrect. Therefore, an amended front page summary sheet must also be filed. **If the campaign did not receive this contribution, please note this fact in a letter to the Commission.**
2. Schedule A (Contributions and Other Receipts) of the January 10, 2020 Receipts and Expenditures Report lists a \$250 contribution being received on 11-15-19 from the KTLA PAC. However, the report filed by the KTLA PAC reports the contribution as \$500. Please check your records to determine the amount of the contribution. If the contribution was \$500, an amended Schedule A must be filed with the correct amount. If the contribution was in fact \$250 as reported by the campaign, please note this fact in a letter to the Commission.
3. Schedule D (Other Transactions) of the January 10, 2020 Receipts and Expenditures Report indicates \$3000 was repaid to Jesse Moore on 12-30-19. This reimbursement is not listed on Schedule C (Expenditures and Other Disbursements). An amended Schedule C must be filed listing this \$3000 reimbursement.
