- Schedule A (Contributions and Other Receipts) of the July 25, 2022 report shows a \$500.00 loan from Nina Fricke on 5-12-22. All loans should also be listed on Schedule D (Other Transactions) until such time as they are repaid or forgiven. An amended report must be filed which includes Schedule D and the corresponding entry on Line 7 of the cover summary page.
- 2. Schedule A (Contributions and Other Receipts) lists a \$91.00 loan on 5-12-22 and a \$120.00 loan on 6-3-22 to Nina Fricke. These loans are listed as expenditures on Schedule C (Expenditures and Other Disbursements) for a PO Box Rental and filing fee for KS House. If these expenditures were paid for personally by the candidate and not deposited or paid through the campaign account, they must be listed on Schedule B (In-Kind Contributions) from the candidate and also on Schedule D (Other Transactions) as loans owed to the candidate until they are paid or forgiven. If they are correctly reported on Schedule A and Schedule C, they would not be considered loans. An amended report must be filed correcting this error.
- 3. K.S.A. 25-4146(b) states, "No contribution or other receipt shall be received or expenditure made, by or on behalf of a candidate, except payment of a filing fee: (1) until such candidate appoints a treasurer and makes the report required to the Secretary of State..." Two contributions were received by the campaign prior to the date the candidate's Appointment of Treasurer or Candidate Committee form was filed on May 16, 2022.

These contributions should not have been accepted. No amendment to the July 25, 2022 report is necessary for this error.
