1. Schedule C (Expenditures and Other Disbursements) of the October 31, 2022 report lists a donation to the Kansas Federation of Democratic Women in the amount of \$40 on 8-9-22.

K.S.A. 25-4157a does not list a contribution made to a political action committee as one of the permissible uses of a candidate's campaign fund. If this expenditure was for a reimbursable campaign expense, that fact must be noted on an amended Schedule C. If this was an actual donation, the Kansas Federation of Democratic Women will be required to return your campaign funds or you will need to reimburse the campaign personally. The return of this donation must be shown on Schedule A (Contributions and Other Receipts) on the January 10, 2024 report.

Schedule D (Other Transactions) of the October 31, 2022 report lists a \$1,240.00 loan payable to Heather Meyer on 8-5-22. However, Schedule C (Expenditures and Other Disbursements) lists reimbursement for the \$1,240.00 loan on 10-5-22. If the loan was reimbursed during the reporting period, it should be removed from Schedule D.
