All loans should also be listed on Schedule D (Other Transactions) until such time as they are repaid or forgiven. An amended report must be filed which includes Schedule D and the corresponding entry on Line 7 of the cover summary page.
- 2. The contributions listed on Schedule A (Contributions and Other Receipts) of the July 25, 2022 report do not total \$3,990.00 as indicated on the front page summary sheet. An amended report must be filed correcting this discrepancy.
- 3. Schedule C (Expenditures and Other Disbursements) of the July 25, 2022 report lists a donation to the Kansas Federation of Democratic Women in the amount of \$40 on 7-16-22.

K.S.A. 25-4157a does not list a contribution made to a political action committee as one of the permissible uses of a candidate's campaign fund. If this expenditure was for a reimbursable campaign expense, that fact must be noted on an amended Schedule C. If this was an actual donation, the Kansas Federation of Democratic Women will be required to return your campaign funds or you will need to reimburse the campaign personally. The return of this donation must be shown on Schedule A (Contributions and Other Receipts) on the October 31, 2022 report.
