The intentional failure to file an amended report within thirty (30) days is a class A misdemeanor. In addition, you may not accept contributions or make expenditures following the end of the thirty (30) day period if the amended report has not been filed.

Additional information and assistance may be obtained by writing or calling this office. If after having contacted this office substantial issues remain unresolved, you may within ten (10) days of receipt of this notice request a hearing before the Commission.

- The July 25, 2022 Receipts and Expenditures Report that was submitted by the Marvin Robinson campaign did not contain a completed front page summary prescribed by the commission. A front page summary sheet for the July 25, 2022 must be completed and submitted.
- 2. Schedule A (Contributions and Other Receipts) of the July 25, 2022 report lists a \$40 cash contribution on July 16, 2022 with the name and address of contributor listed as "Unknown". K.S.A. 25-4154 (b) states, "No person shall give or accept any contribution in excess of \$10 unless the name and address of the contributor is known to the individual receiving the contribution." An explanation for this \$40 contribution must be provided in a letter to the Commission. If the campaign is not aware of the name of the contributor of this contribution, \$40 must be expended in a non-political manner since this would be an illegal contribution.
- 3. Schedule A (Contributions and Other Receipts) lists a loan from Broderick Henderson on May 31, 2022 for the filing fee of \$120.00. However, the payment for the filing fee is not listed on Schedule C (Expenditures and Other Disbursements) and must be listed if the filing fee was paid through the campaign account. If the filing fee was paid personally by Broderick Henderson and the \$120 was not placed in the campaign bank account or paid through the campaign account, it must be removed from Schedule A and listed on Schedule B (In-Kind Contributions). An amended report must be filed correcting this error.
