Additional information and assistance may be obtained by writing or calling this office. If after having contacted this office substantial issues remain unresolved, you may within ten (10) days of receipt of this notice request a hearing before the Commission.

- 1. Schedule C (Expenditures and Other Disbursements) of the July 25, 2022 report lists expenditures totaling \$8,968.37, yet the cash available this period indicates a balance of \$2,060.00. If the \$9,000.00 cash contributions from the candidate that are listed on Schedule B (In-Kind Contributions) were deposited into the campaign account, they must be reported on Schedule A (Contributions and Other Receipts), not Schedule B. Contributions deposited in the campaign bank account and expenditures made from that account are to be reported on Schedules A and C. An amended July 25, 2022 report must be filed correcting this error.
- 2. Schedule A (Contributions and Other Receipts) indicates your campaign accepted the following cash contributions over \$100:

K.S.A. 25-4153(i) states, "No person shall make any contribution or contributions to any candidate or the candidate committee of any candidate in the form of money or currency of the United States which in the aggregate exceeds \$100 for any one primary or general election, and no candidate or candidate committee of any candidate shall accept any contribution or contributions in the form of money or currency of the United States which in the aggregate exceeds \$100 from any one person for any one primary or general election."

The cash contributions listed above should not have been accepted by the campaign. In the future, you must be certain that all contributions in excess of \$100 are made by check, cashier's check, money order or e-funds.

- 3. Schedule C (Expenditures and Other Disbursements) lists an expenditure on 7-18-22 to Dennis4SBOE7 in the amount of \$5,289.27 for the printing of a mailer. Schedule C must be amended to list the name and address of the vendor that printed the mailer.
- 4. The July 25, 2022 report did not disclose a payment to the Secretary of State for the candidate's filing fee. If the filing fee was paid by the candidate from personal funds,

it should be recorded on Schedule B (In-Kind Contributions) as an "in-kind" contribution from the candidate to the campaign. If the filing fee was paid from campaign funds, this expenditure should be listed on Schedule C (Expenditures & Other Disbursements). The July 25, 2022 report must be amended by showing the payment of the filing fee either on Schedule B or Schedule C and on the cover summary page.
