Any expenditures made from personal funds which are not deposited into a campaign bank account are to be reported on Schedule B as in-kind contributions from the donor in addition to being disclosed as a loan on Schedule D. An amended Schedule B (In-Kind Contributions) must be filed listing the in-kind contributions.
- 2. Schedule D (Other Transactions) of the January 10, 2022 Receipts and Expenditures Report lists loans payable totaling \$7,597.24 to Sydney Carlin.
