1. K.S.A. 25-4153 (a)(1) states, "The aggregate amount contributed to a candidate and such candidate's committee . . . shall not exceed the following: for member of the house of representatives, . . . \$500 for each primary election . . . and an equal amount for each general election." The Pickert campaign reported receiving two, \$500 contributions on 6-7-22 from Rodney Stevens II. It appears this could be a duplicate entry. If so, an amended Schedule A (Contributions and Other Receipts) must be filed removing the duplicate entry. If the campaign did receive two, \$500 contributions, both of these contributions were received during the primary election period and \$500 must be returned. **The return of this contribution should be noted on Schedule C (Expenditures and Other Disbursements) of the October 31, 2022 Receipts and Expenditures Report.**
2. K.S.A. 25-4146(b) states, "No contribution or other receipt shall be received or expenditure made, by or on behalf of a candidate, except payment of a filing fee: (1) until such candidate appoints a treasurer and makes the report required to the Secretary of State..." Two contributions were received by the campaign prior to the date the candidate's Appointment of Treasurer or Candidate Committee form was filed on May 16, 2022.

These contributions should not have been accepted. No amendment to the July 25, 2022 report is necessary for this error.

3. Schedule C (Expenditures and Other Disbursements) must be amended to include the street or mailing addresses for all individuals and vendors to whom expenditures were made during the July 25, 2022 reporting period.
